## I. Welcomes & Introductions

### Guest Speaker Raman

Council Member Raman's office contacted us today to let us know that she is unable to join us tonight (Agenda Item II) We apologize to everyone who is here because they were looking forward to hearing her speak. I'd also like to thank those of you who submitted questions for her in advance of today's meeting.

We have rescheduled her for a special meeting two weeks from tonight on WED January 27<sup>th</sup> at 7pm and will ask her those questions at that time. That means that if you weren't able to send in your questions for the Council Member before, you have time to do it before the 27<sup>th</sup>. It also means that she will be the only speaker on the agenda that night, so we will have more time with her.

Before we move onto the other agenda items, we would like to let you know that we have several important guest speakers already signed up for the first part of this New Year. In February, we have the LAPD Hollywood Division Commander, Captain Steve Lurie. In March we have LA City Attorney Mike Feuer. In April we have LAFD Deputy Chief Armando Hogan. We have also reached out to US Congressman Adam Schiff's office and State Assembly Member Laura Friedman's office with invitations to speak but we don't have confirmed dates yet.

### La Rocha Trail Fire Update

On Monday afternoon a fire broke out on the hillside at the west end of the La Rocha Trail. Several quick thinking neighbors called it in and attempted to assist with fire extinguishers and a bucket brigade. LAFD had 55 fire fighters on the scene from multiple fire stations, and two water dropping airships respond. It took approximately 39 minutes to knock it down. We were fortunate that it occurred during a day with very little wind, and that the wind was blowing the flames away from nearby structures. The cause of the fire has been confirmed as accidental, resulting from a careless teenage smoker.

We have reached out to Deputy Chief Hogan, and we will be doing a site walk through with the Battalion 5 Commander to discuss the special challenges for fire response to our neighborhood. We will be working on establishing a strategy with LAFD to ensure they have the information they need in advance of an event so that they can have the best possible conditions for success.

The HDCA will continue to take steps to alert neighbors of the fire danger in the area. Additionally, we will be contacting property owners along the north side of the La Rocha Trail who have not done adequate brush clearance. HDCA will also be installing “no smoking / fire danger” signage near the benches where people have been smoking while enjoying the view.

#### Crime Numbers for 2020

Overall in her area (north of Franklin to Barham, the 101 freeway to Western) was down 13% compared with 2019. This is in contrast to the City of Los Angeles overall, where they have seen significant increase. She thinks it's possible that because the bars and nightclubs in the Hollywood Entertainment District were closed for the pandemic, that the resources usually needed in those areas got redeployed to the hill areas which helped keep crime down overall.

#### COVID-19 Update

As of today there are over 2000 officers (of the 10,000 total) who have tested positive. LAPD is Tier 1B for the vaccine distribution. As the LA Fire Department has extra doses they are calling in the police to come get them so they don't go to waste (they are no good after an hour of being defrosted).

#### LAPD Personnel Changes

They were notified last night (January 12) that they were planning a 1,000-officer cut. It's not final yet. They will have final answers by May/June of this year.

*Q: There seems to be an increase in nuisance activity at the Vine Overlook (near the Vedanta Temple).*

*A: This has historically been a problem spot. Officer Mata has advised patrol to do extra patrols to this location. She also encouraged residents to report problems to the non-emergency number (877) 275-5373. Or email the station [Hollywood@lapd.online](mailto:Hollywood@lapd.online) to let them know what's happening.*

*Q: What is happening with the changes coming from the newly elected District Attorney Gascon for example with not prosecuting trespass violations?*

*A: There are certain misdemeanors that his office will not file on. LAPD will still respond to these calls, the difference is what happens next.*

Trespass Authorization forms and signage. Property owners need to have a “trespass authorization form” on file with LAPD, and post the appropriate signage so that responding officers have the authorization to arrest someone on your property. Officer Mata will submit the forms if we send them via email to her.

### New Directives from District Attorney Gascon

The District Attorney has jurisdiction over all of the most serious felony crimes in Los Angeles (murder, trafficking, drugs, rape, etc.) He also has jurisdiction over misdemeanor crimes in the unincorporated areas of Los Angeles County. Because the City of Los Angeles has its own City Attorney's office, they handle the prosecutions of misdemeanor crimes (trespass, prostitution, etc.) that occur within the City.

The LA City Attorney has no plans to follow Gascon's lead. They will continue to try to use the criminal justice tools to get people into the services they need. This means using trespass arrests to get people mental health services, or prostitution arrests to help people who may be victims of human trafficking. The goal is to help those people, but also to keep the public safe.

*Q: Why do they have to use the criminal justice system to assist people with the services they need?*

A: Because we don't currently have an alternative, we don't have laws or mental health facilities to handle these situations. They do the best they can with what they have to work with. They are also losing tools such as "stay away" orders as a condition of probation (from 3 years to 1 year). The state has also given judges the discretion to ignore the recommendations of the prosecutors.

Ethan requests our community to reach out to him and share questions or issues that matter to us.

*Q: Have they spoken to elected officials / decision makers about the need for more mental health and substance services?*

A: He encourages us all to ask, because the more people who press for this the more likely we will get action.

*Q: What are the current rules about parties under the SaferLA order?*

A: ANY private gatherings that include people from outside your immediate household are currently prohibited due to the COVID-19 surge and emergency orders.

*Q: Why can't the trash and mess under the 101 near the service station on Franklin & Argyle get cleaned up? It appears to be an abandoned encampment. Why can't it be cleaned up tomorrow?*

A: There are jurisdictional issues because areas like this are technically Cal Trans property and the City doesn't have the authority to go and deal with it.

A: Contact our State Assembly Member, Laura Friedman's office to ask for help with this. Her field deputy for our area is Seamus Garrity, his email is: [seamus.garrity@asm.ca.gov](mailto:seamus.garrity@asm.ca.gov)

A: George also commented that HUNC has voted to send a letter to Gov Newsom about this problem. Cal Trans reports to the Governor.

A: Prior to the pandemic they worked closely with the CD4 and the County to help tackle these issues. They look forward to working with newly elected CM Raman to address this issue.

#### Proposed 711

At the location of Cesar's Auto Shop (6201 Franklin Avenue at Vista Del Mar) they are proposing a redevelopment project to put in a 711. HUNC Planning and Land Use Management Committee will be discussing this at the meeting on THU February 4, 2021 at 6:30 pm. It will also be discussed at the Board meeting on MON February 8, 2021 at 6:30 pm. Those who have concerns/objections or want to voice support are encouraged to participate in these meetings. HUNC's role is to provide a forum for the community to give feedback to the City.

*Q: If community members aren't able to make the meeting, is there another way for them to get their input heard?*

## **IV. HDCA Business / Updates**

### Filming Committee

At the end of 2020 HDCA formed a new committee to work on issues related to filming production in our neighborhood. Committee chair is Jodi Ehrlich and other members are our Treasurer Kelly Ziegler, our VP David Brewer, and past president and film industry professional, Peter Barnett. The HDCA has already established a protocol with Film LA to notify us whenever filming permits are applied for in our neighborhood. The primary goal is to advise production companies of public safety concerns, fire danger and parking issues to minimize the negative impact of filming in our neighborhood. We are NOT anti-filming, but rather pro responsible filming.

### Little Free Library Branches

The libraries will be finished and installed within the next couple of weeks. If anyone has been doing a New Years clear out and has books, there will be 5 new LFL to donate to.

### Vine Overlook Committee

We are reactivating this committee due to the increase in nuisance activity at the Vine Overlook. The HDCA will be brainstorming on actions we can take to make this entrance to the Dell welcoming and at the same time discourage those who are creating disturbances, litter and other illicit activities. The neighborhood watch isn't just about crime; it's our way to look out for each other whatever the emergency is (fire, earthquake, pandemic...).

When the fire happened on Monday, we were able to notify our entire street using our watch list so that those who saw the smoke but didn't know where it was happening could be advised of the fire and assured that LAFD was on the scene.

### Project SHARE

HDCA has received several complaints / questions from residents who live near 6295 Ivarene. They are concerned about the un-permitted construction and number of occupants at this location. In mid December, one of the occupants was taken into custody under a 5150 hold (mental health) because of an attempted suicide. We reached out to Allison Schallert, who lives in the Dell but also works in the non-profit world as an advocate for affordable housing solutions to help with the homelessness crisis. She spoke with the folks that run Project SHARE and this is what she learned:

Project SHARE is a model for group living for people on a shared recovery journey. They have been in operation for over 9 years and are a reputable company. There are no onsite managers or support services 24 / 7, rather it is peer-based support. They are open to coming to a meeting and speaking if we would like to learn more.
