### RENT DEBT RELIEF

On July 1, 2021 CM Raman presented a motion to explore relief options for small businesses that have accumulated rental debt during the city-wide lockdown in response to COVID-19.

### STORAGE & SANITATION

Also on July 1, 2021 CM Raman presented a motion to improve storage and sanitation for unhoused Angelenos. This is an effort to remedy the lack of available storage space for people experiencing homelessness. Being unable to secure their possessions is often a barrier to leaving an encampment and accepting services or work opportunities.

### FIRE SAFETY EVENT

July 22, 2021 (5 – 6 pm), CM Raman will be joined by: LAFD West Bureau Commander, Chief Armando Hogan and LAFD Brush Clearance Division, Captain Bryan Nassour for a discussion around fire safety and evacuation preparedness in high fire zones.

### STREET SANITATION

Due to budget cuts there has only been one sanitation team assigned once a week. Now they will have LA SAN CARE teams working 5 days a week. This should help with keeping the encampments clean, safe and ADA compliant.

### HOLLYWOOD DELL PENDING ITEMS

Vine Overlook. Helene is working on getting the improved fencing and security light.

Hollywood Gateway Triangle. The illegal restaurant activity has been stopped and their office is coordinating the other enforcement and they are working to get the area restored.

### Special Recognition

Helene presented a special recognition certificate to HDCA youth volunteer Joaquin Pont.

#### COVID-19 Updates

LA County Public Health Department is recommending that even fully vaccinated people wear masks in public places wear they don't know the vaccination status of those around them. Right now the infection rates are up 500%, it's been the 6<sup>th</sup> day in a row that there are in excess of a 1,000 new cases. Only 61% of residents (over the age of 16) are fully vaccinated. That 39% that aren't fully vaccinated makes up nearly 3 million residents.

#### Measure H Project

The Board of Supervisors approved \$527 million dollars to a vast array of initiatives addressing the homeless. Short and long term permanent supportive housing, rapid re-housing, street outreach, and homelessness prevention. Supervisor Kuehl is focusing on prevention.

They are now accepting decline in value review applications for property owners that have experienced a loss of value due to the pandemic.

Alexa thanked Seamus for the amazing work done to clean up and put in new plantings around Highland off ramp near Cahuenga and Odin. Seamus has worked with CD4 and CALTRANS to work on areas around the 101 freeway. CALTRANS has lost 50% of their maintenance team due to the pandemic.

#### SB 9 & SB 10

While these two pieces of legislation are designed to address the housing crisis, they are very unpopular in our district. Seamus encouraged everyone who has a concern to send your feedback to AM Friedman. It is still moving through the legislative process and hasn't come before the Assembly yet. Until it is presented to the Assembly, she won't be able to make a statement on it.

#### AB – 43 Traffic Safety
