About Mike Feuer

Mike Feuer was first elected Los Angeles City Attorney in 2013 and was re-elected in 2017. Prior to that he represented the Hollywood Dell as our California State Assembly Member for the 43rd District. Some of you may recognize him from the Dell BBQ & Pet Parade, or the La Rocha Trail and Franklin Ivar Park dedication events or maybe from a neighborhood meeting like this. Tonight we have invited him to speak about his role as City Attorney and his thoughts about the important challenges facing Los Angeles.

The Role of the City Attorney

The City Attorney writes every municipal law, advises the Mayor and the City Council on every issue that has a legal dimension to it, defends the city in litigation, and brings forth lawsuits on behalf of the people. His office is one of the largest prosecutorial offices in the United States; they prosecute misdemeanor crimes (the DA prosecutes felony crimes). He doesn't look at conviction rates as a measure of success, but rather the reduction of recidivism.

Mr. Feuer touched on a variety of topics; spoke about the challenges facing Los Angeles and shared his thoughts about how to best address various issues.

Mr. Feuer also answered questions from our community:

Q: What about adding the consequence of a utility shut-off to the Loud Or Unruly Ordinance as one of the penalty options for repeat violators (after the mayor's emergency order is lifted)?

A: He thought that could be done, it requires a change in the Ordinance that would have to be initiated by the City Council. He underscored that the utility shut-off has been quite effective. He also understands that party houses are more than a noise issue, there is an important public safety aspect in neighborhoods like ours.

Q: What about the impression that there's an overall lack of enforcement by the City for existing laws & ordinances?

A: He agreed that there's not enough enforcement and that needs to change. He gave the example of the shortterm rentals, he hasn't seen a second round of citations given (by the Planning Dept.) and he knows that there are many locations that are repeat offenders. This needs to change.

Q: His thoughts on the efforts to "defund" the LAPD.

A: "Defunding the police isn't just a bad slogan; it's a bad idea." He does support efforts to fund alternative programs for mental health crisis teams and supporting underserved communities. LAPD shouldn't be asked to respond to some of the things they have been because a lack of alternatives.

Q: Why are these large encampments in our area such as Gower (under the 101 Freeway) allowed to spill into the streets? Do people have a "right" to live like this on our public streets?

A: He feels that we should have a goal to end street homelessness in the next five years. We should lead with housing and services but also, there's no "right" to live on the street.

Q: What about people who are lighting fires, using drugs, leaving needles on the ground, there are those who block the entire sidewalk and not leave room for a wheel chair?

A: No one should be allowed to block a sidewalk, they should allow for 36" of passable space. No one should be allowed to start a fire in a dangerous situation. Drug possession has largely been made a misdemeanor with very little consequence due to Prop 47, but drug sales, prostitution, and gang activity in encampments should be enforced. Criminal behavior should not be overlooked simply because someone is un-housed. Rules should be enforced.

<u>"Hero Pay"</u>

On March 3, 2021 the LA City Council approved the \$5 / hour boost for grocery store workers (aka "hero pay") as an emergency ordinance. This will apply to all non-managerial employees at grocery or drug retail stores with more than 300 employees nationwide or more than 10 employees on site. It will be given in addition to employees base wages for the next 120 days.

Reduction In Street Sweeping

Street sweeping services in the city of Los Angeles will be reduced to every other week starting March I, 2021 due to the COVID-19 pandemic and staff reductions. LA City Council voted this week to direct the \$150 million cut from the LAPD budget to re-invest in support of Los Angeles' most underserved communities of color. They also voted on a plan to devote substantial resources to develop an unarmed alternative to armed police response.

Holly Drive Street Work

The city is working on several improvements between on Holly Drive (between Dix & Odin). They will be repairing sidewalks and installing wheel chair accessibility on the corner crossings. They have posted "no parking" along this section of Holly Drive. No confirmed date when this will all be finished. While this is an inconvenience for residents who normally park along Holly, the end result will be a welcome improvement.

Deep Dell Sewer Work

The sewer work being done on Deep Dell Place is for two permits issued in January & February 2021 for 6372 Weidlake Drive. The permits expire 2 years after they are approved (January & February 2023).

San Marco Drive

Residents have reported concerns about landslide issues from a vacant lot on San Marco Drive. Sarah will contact LAFD in to take a look at the issue.

COVID-19 Status in LA County

Los Angeles had been in the "purple" tier, which is the worst (aka widespread) up until recently. However, this week we have now moved into the "red" tier (aka substantial). The metrics being used to assign the tiers are:

- New COVID-19 cases per day per 100K people
- % Positivity Rate (7-day average)
- Vaccine Equity is a new metric they are looking at

Vaccinations

As of Monday 2.4 million doses have been administered and of those, 815K were people getting their second doses. Of the 312K doses that are being distributed to the 375 vaccination sites this week, 54K were the new single dose Johnson & Johnson vaccine.

Who Can Get The Vaccine Now

In addition to those who were already eligible with Phase IA (healthcare workers, staff & residents of skilled nursing facilities and those 65+) eligibility was expanded this month to include Phase IB for the following sectors:

- Childcare & Education Workers
- Food & Agriculture Workers
- Law Enforcement & Emergency Service Workers
- Custodians & Janitors
- Public Transit Workers
- Airport Ground Crew Workers
- Social Workers & Foster Parents

The Hollywood Dell Civic Association (HDCA) Film Committee was established to ensure the Hollywood Dell is a positive place for film production for both the film production companies and the neighborhood residents. The primary role of the committee is to create awareness, share information and

act as a resource so that filming activities are done within the established rules and permit guidelines, that public safety is observed and that the impact on the neighborhood is minimal.

We are working with FilmLA, which is the organization that operates as the official film office for the City & County of Los Angeles. FilmLA is advising us whenever a permit is requested within the Hollywood Dell, but if you receive a notice or survey from FilmLA, please let Jodi know so we can keep track and make sure everything is going as it should.

The HDCA will notify our email subscribers whenever there is a film permit granted within the Hollywood Dell, regardless of the size, type or location of the production. There have been 9 permitted film productions in the Hollywood Dell so far in 2021. There were also 2 additional film productions on the borders of our neighborhood (Agyle and Franklin) that involved parking and road closures. There is no limit to the number of days that filming can occur at a location.

The committee has already drafted handouts for production companies about filming in our neighborhood and is working on creating a handout for residents who may be considering hosting filming at their home.
