Anthony gave an update on the Franklin / Wilcox / Cahuenga triangle. The City has installed the new irrigation system and is getting ready to do the re-planting this month. He has also requested that the General Services Division (GSD) look into lighting the sign. Someone asked if the people responsible for the taking over of the triangle would be held financially responsible for the replanting expenses. He couldn't give specifics but did say that yes, reimbursement was part of the judgment they had asked for.

Alexa mentioned that she has asked for Anthony's help with strengthening the language and penalties for the Loud Or Unruly Ordinance (aka "party house" ordinance). We would like to see the utilities shut off that was used temporarily under the Mayor's emergency orders during the pandemic applied as a permanent part of the ordinance.

Alexa also mentioned the Home Sharing Ordinance (aka "short term rentals" ordinance) needs to be strengthened and there needs to be much improvement on enforcement.

We thanked Josef for providing the free Department of Sanitation compost pails at our February meeting. We asked that we get pails for the in-person meeting in April as well as a way to make it convenient for Dell residents and he agreed. He is also working out of the Hollywood City Hall 6501 Fountain Avenue.

Josef announced that our request for \$2,500 in funding support for our annual Hollywood Dell Summer Block Party was approved!

He confirmed that he would make sure that CD4 provide a team to to haul away the trash on our Neighborhood Cleanup Day on SAT April 22<sup>nd</sup>. We also discussed getting the LA Beautification Team to assist with other efforts. In the past they have cleaned the Holly and Ivar tunnels.

We had inquired about the status of the Cement Streets Pilot program. Josef said this program was under the previous CM David Ryu and that it is no longer in place. He did say that we should send him any streets that we thought needed repair or repaying so that he could make sure they are on the list with Street Services.

We also asked about missing parking signs throughout the Dell, especially on problematic streets that should be No Parking – Tow Away because of emergency access. He will coordinate with Alexa on identifying the streets and working with LADOT to get signs put up.

There were questions about all the new potholes as a result of the heavy rains. These are serious potholes that can cause damage and injury. Josef suggested sending him the location even if you have reported it already on 311 – he can assist with making sure they are getting repaired.

Marilu attended our meeting to discuss the Neighborhood Councils and to encourage Hollywood Dell residents to consider participating on a NC committee or as a board member. She said that not enough certified candidates applied to run for the open seats in the April HUNC election. This means they can't hold the election. They will be using a process called "affirmation," which is essentially to appoint people, to fill board positions until the next election.

The City of Los Angeles has 99 Neighborhood Councils. They are advisory boards that advocate for their communities with City Hall. They are part of the LA City Government and have annual budgets funded by taxpayer dollars. Councils are comprised of volunteers who are elected by their communities.

The Hollywood Dell falls within the borders of the Hollywood United Neighborhood Council (HUNC).
