# II. Where We Are Today

### Temperatures, Humidity & Winds

The combination of warm temperatures, low humidity and extreme winds make for high wildfire danger. Last week we saw the tragic results of those conditions. Thankfully the humidity today was up 33%, the winds have calmed and temperatures are cooler. For the next several days winds should be light and variable (3 - 5 mph).

### **Red Flag Restrictions**

LAFD sent out a notice that they will be lifting the Red Flag restrictions starting tomorrow (Thursday, January 16) at 8am.

### Leaf Blower Ban

LA County Health Department has put a temporary leaf blower ban in place because of the highly hazardous ash accumulation from area wildfires. *That means NO BLOWERS* – so please let your regular gardeners / landscapers know. Blowers stir up the toxic dust and ash and cause harmful conditions. This ban will be in place until they determine that conditions have sufficiently improved.

### Air Quality Index (AQI)

Today's AQI was 22 – which is considered "good" after excessively high AQI days earlier in the week that is good news. We had levels over 150 AQI in our area just days ago.

The chart attached shows levels and health concerns. Masks are recommended outside, especially for sensitive groups.

### Recent Water Main Break on San Marco Drive

Tuesday about 6:15 pm a LADWP water main broke. Residents called 9-1-1 and the fire department responded quickly, but it took over an hour for LADWP to arrive and another 20 minutes for them to figure out how to shut it off. Two cars were flooded and stranded on Cahuenga. A motorcyclist was taken away in an ambulance. Several homes were damaged on San Marco Drive.

Containment: 50% 61 acres burned

Mountain Fire (San Bernardino)

Start Date: January 15, 2025

Containment: 0% 30 acres burned

The Sunset Fire (Hollywood Hills)

Start Date: January 8, 2025 Containment: 100% 43 acres burned

## IV. FIREWISE

Frank Shotwell shared information about a program called FIREWISE. It is a program organized by the National Fire Protection Association (NFPA). It is a free, voluntary program that helps communities reduce the risk of wildfires, encourages neighbors to work together to take action to make their homes and neighborhoods fire resistant. Once a community has gone thru the steps and has been designated as a FIREWISE site, it can help reduce insurance rates. It also sends a message to the fire department that we are working in partnership with them. For our whole Hollywood Dell neighborhood (1,100 residences) it would mean a commitment of annual hours / money spent.

Frank has volunteered to head up a committee. Anyone who would like to work with him, please let us know.

# V. Neighborhood Watch

Neighbors Looking Out for Each Other...

#### Franklin Ivar Park Arson Incident

Saturday, January 11, 2025 at approximately 6 pm residents noticed a man lighting a bunch of dried leaves and branches on fire in Franklin Ivar Park. They interrupted him and doused the fire but he disappeared before LAPD arrived. One of them was able to snap a photo of him lighting the fire. HDCA contacted Senior Lead Officer Heather Mata who was not working in the area that night (LAPD has been deployed all over LA for wildfire duties) but she shared the image with the Hollywood Watch Commander who distributed it to all the officers working in Hollywood that night.

### **Encampment On the Hillside Above San Marco Drive**

Several residents reached out that the man (who has previous convictions for arson) that has been encamped on and off on the hillside above San Marco Drive (below the Cross) was back and had open flames in his camp. HDCA alerted the Hollywood Bowl Management, and LA County because that is their property, and LAPD to get him arrested for lighting fires during a red flag alert, and trespassing. He was taken into custody by LA County Sheriff's at 12:30 pm on Monday, January 13<sup>th</sup>.

### **Temporary Private Security Patrol**

With the weather forecast for another high wind event Monday – Wednesday of this week, and multiple reports of people lighting fires in our area, a group of over 40 neighbors organized and hired a private security company to patrol their streets 6 pm – 6 am on those 3 days. The Eaton Fire (Altadena) falls within Supervisor Barger's District. She has introduced a motion to declare a state of emergency to begin the rebuilding and recovery process.

LA County has opened a Disaster Recovery Center at Pasadena City College.

Jan asked any of the new people at the meeting to give her their information via the chat.

Q: Can we get someone to come to one of our in-person meetings to talk about insurance? I am afraid to contact my insurance company for clarification because I'm worried it might trigger them to raise my rates or drop me!

A: We will reach out to Beachwood Canyon Association. They had a meeting a few months ago on this topic and may be able to help us with this.

Q: There seems to be a lot of brush (aka fuel) everywhere. What can I expect from my neighbors to take care of this? Also the area around the Lake Hollywood Reservoir...

A: The Reservoir is LADWP property. Report it to LADWP and make sure to cc our rep in our LA City Council District 4 office.

A: Having your immediate neighbors organized in a watch group should help you share concerns. Q: Have we considered using goats to clear hillsides of brush?

A: A few people in the Dell have looked into it in the past, but were told they didn't have enough land to do it, but let's look into it.

Debra Gainor suggested getting a group going using What's App for communication for block captains. The night of the Sunset Fire, it was helpful to know which neighbors were evacuating and which ones were staying. Schelley chimed in and suggested that we consider doing it for the entire Dell.

### Apartment Project On Cahuenga Blvd.

Diane Alancraig mentioned that the LA City has approved a large, project on Cahuenga just north of the 101 freeway.

Project Location: 2100 Cahuenga Blvd. (addresses include 2042, 2044, 2048, 2048 ½ and 2100)

This project is for a 5-story, 182 units (72,880 sq ft) 100% affordable apartment building. It falls under the EDI order. EDI is Mayor Bass' Exective Directive to expedite the processing of shelters and 100% affordable housing projects in the City of Los Angeles.

This is the Emergency Alert System for the City of Los Angeles

It is a mass notification system used to provide emergency information regarding necessary protective actions, such as evacuation orders, to Los Angeles residents, businesses and visitors. The alerts are sent via recorded telephone messages, text messages and emails in the event of emergencies.
